

# **TRAVEL BENEFIT REIMBURSEMENT**

We're committed to ensuring that our members have access to the care they need. This new benefit covers certain travel expenses for covered services that aren't available within 100 miles of your home.

#### Benefit Overview

Blue Cross Blue Shield of Massachusetts will reimburse you for certain expenses related to travel to obtain covered services.

- The benefit does not cover travel costs for routine, preventive, or elective care.
- You must need to travel at least 100 miles from home to obtain these services.
- The services you obtain must be from a covered provider in your service area. See your benefit details for service area information.
- You must maintain receipts for all travel, and we may ask for them at any time. The reimbursement form requires your signature, attesting that the travel receipts are accurate and were incurred in accordance with this travel benefit.
- We'll also reimburse the covered expenses, when necessary, for one companion traveling with you. They don't have to be a Blue Cross member.

To be eligible, your employer must opt in. To see if you're eligible for this benefit, call Member Service at **1-888-420-4501**.

## How to Be Reimbursed

To be reimbursed, submit a form to Blue Cross Blue Shield of Massachusetts. A request form is included with this document.

## What This Benefit Covers

**Round-trip transportation**, to obtain the covered service, including air, train, bus, taxi and ride-sharing service, car rental, tolls, and parking, will be reimbursed between your home and the location where you receive the covered services.

- Airfare is limited to commercially scheduled coach-class tickets and won't count toward a daily travel maximum if one has been established by your employer.
- **Mileage** is based on the current Internal Revenue Service (IRS) medical mileage reimbursement, which includes gasoline.

**Lodging:** Your hotel or motel may be reimbursed up to \$50 per person per night (up to \$100 if you travel with a companion).

**Please note:** There may be a limit on the amount you can be reimbursed. To confirm your benefit allowance, call Member Service at **1-888-420-4501**.
